HMIS / Coordinated Entry - Brian Robison

- Committee discussion about case conferencing. We have a basic flow.

- We had the office manager from BnB Real-estate who took over 7 trailer parks. This meeting left us with a discussion on redeveloping our pitch.
- We are putting together an event for landlord engagement and looking at dates.

- I have requested some TA from Gillian and waiting to schedule that.
- I am gathering all the HUD, State, County and Coc requirements on equity and inclusion before I schedule an equity meeting.

- We just received the first 20% of HHAP 3.
- NPLH grant is for Coliar Ave project through the county.
- Melissa We received a debriefing back from the HUD CoC Competition Application. I will analyze it and bring back what I have found next month.


